Selection of suitable bidder/ selling of vehicle-

If the highest offerer back out then the item will be offered to the 2nd highest offerer and in that case the EMD of defaulting bidder will be forfeited. Bank is not bound to sell the vehicle below its base price/ value.

Schedule of Payment-

Highest price offering bidder has to deposit the 100% of buying amount (excluding EMD) within 7 days from date of opening of tender , Payment would be received only through DD/ NEFT.
