I/We agree to abide by the provisions of Foreign Currency (Non-Resident) Account/Non-Resident (External) Account and Non-Resident Non-Repatriable (Rupee) Scheme. I/We hereby undertake to intimate you about my/our return to India for permanent residence immediately on arrival.

I/We agree that if the premature withdrawal is permitted at my/our request, the payment of interest on the deposit may be allowed in accordance with the prevailing stipulations laid down by Reserve Bank of India in this regard.

I/We authorise the bank to automatically renew the deposit on the due date for an identical period unless the instructions to the contrary from me/us is received by the bank before maturity. I/We understand that the renewal will be in accordance with the provisions of the Reserve Bank of India Scheme in force at the time of renewal.
