Other Terms and Conditions:

- 1) All intending bidders shall register with the e-auction portal to create their user id's and passwords. Bidders have to register online by providing their KYC documents and registration fees as prescribed by Service Provider (BAANKNET). Once the kyc documents are verified by BAANKNET, the registration will be activated within a period of maximum two working days from the date of submission of all KYC documents and registration fee, if any.
- 2) The interested bidders has to deposit EMD amount in his/her wallet (virtual) created by the service provider for bidding purpose, Service provider (BAANKNET) will transfer the EMD of the accepted lots to the designated bank account as mapped with the sold property on the next working day after conclusion of auction, Such transfer will be online..
- 3) **Only those bidders holding valid user ID & Password and confirmed wallet (virtual) created by the Service Provider for bidding purpose, Service provider (BAANKNET) shall be eligible to participate in the on line e-auction.**
- 4) The Authorized Officer reserves the right to accept any or reject all bids, if not found acceptable or to postpone/cancel /adjourn/discontinue or vary the terms of the auction at any time without assigning any reason whatsoever and his decision in this regard shall be final.
- 5) The bidders shall improve their offer in multiple of **Rs.50,000/- (Rupees in words Fifty Thousand only)**. In case bid is placed in the last ten minutes of the closing time of the auction, the closing time will automatically get **extended for ten minutes**.
- 6) Auction would commence at the reserve price and bidders shall improve their offer as stated hereinabove. On closure of 'on line auction', the highest bidder shall be declared as successful bidder and such sale shall be subject to confirmation by the Secured Creditor.
- 7) The successful bidder shall have to deposit 25% of the bid/sale amount immediately and the earnest money shall be adjusted towards 25% of the bid/sale amount. encumbrances on the property including statutory liabilities, arrears of property tax, electricity dues etc.


