DETAILED TERMS & CONDITIONS ARE GIVEN BELOW:

1. Scope of work:-

- (A) We have 62 Branches, 51 onsite-offsite ATMs and one Zonal Office under Nagpur Zone situated in 16 various districts of Maharashtra. District-wise position of Branches shown in **Annexure- 'D'** of this advertisement.
- (B) Our Branches premises size may vary from 800 sq. ft. to 2000 sq. ft.
- (C) Work is of doing Electrical audit of Branches and ATMs for fire safety, energy saving & assessment of compliance of statutory guidelines of state electricity department.
- (D) Electrical auditor should submit their report in prescribed format attached herewith as **Annexure- 'E'**, offer their recommendations & suggestions.
- (E) Upon receiving the duly filled Electric audit report from Electrical auditor(s), Bank/ Branch will arrange to rectify the deficiencies through at their own sources. After rectification of deficiencies pointed out in Electrical audit of a Branch/ ATMs. If Bank required to confirm the status of compliance of the same, then Bank can assign the work of Post rectification Electrical audit of any specific Branch to Electric auditor. Post deficiencies rectification visits for assessment of level of rectification can be required for selected Branches.
- (F) Estimated cost of work for 62 Branches, 51 offsite- offsite ATMs and one Zonal Office would be Rs. 1.5 – 02 lacs (approx).

2. Eligibility Criteria of the bidder Engineer/ agency:

- Applicant can be individual / organization.
- Applicant should possess the valid degree (not diploma) in Electrical Engineering accredited by BEE (Bureau of Energy Efficiency). Photocopy of such certificate must be submitted with the application.

6. **Evaluation of Bids:** Part (I) Eligibility bid would be opened first, bidders who qualified in the evaluation of their eligibility bid are only considered for empanelment & evaluation of their financial bids Part-II.

Bank reserve right to negotiate with lowest bidder.

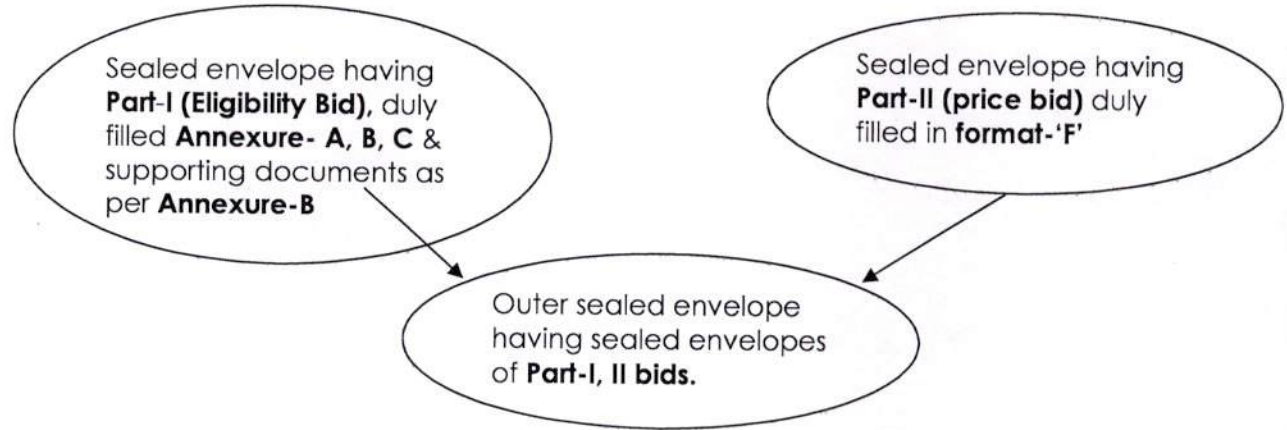

TERMS & CONDITIONS:

A) GENERAL TERMS & CONDITIONS:

- 1) The Successful Bidder(s) will be engaged for doing 'Electrical Audit' of Branches/onsite- offsite ATMs / Office situated in 16 different district of Maharashtra State under Nagpur Zone of UCO Bank. (District wise list of Branches is shown in Annexure- 'D')
- 2) The work is to be started in consultation with Security Department/ General Administration Department of UCO Bank, Zonal Office Nagpur.
- 3) The Successful Bidder will have to carry out the work without making hindrances to other agencies, whose works are likely to be carried out simultaneously at the same site during working hours.
- 4) The Successful Bidder will take all measure on the site of the work to protect the public, our staff as well as their workmen from accidents and shall be bound to bear the expenses related to loss /damage to property, loss of life/ injury / medical treatment of any person caused by the act of person doing Electrical audit and defense of every suit, action or other proceedings at law that will be brought by any persons for injury sustained owing to neglect of the above precautions from their end and to pay compensation to any such persons as per Law.
- 5) The Successful Bidder will have to inform the names of their authorized Engineer /representatives to be deployed at the site for the work. Bidder will submit a verified copy of electrical engineering certificate along with two passport size photo of the staff or representative, who will be allotted for doing the Electrical audit work in our Branches /ATMs onsite-offsite/ Offices. Authorization to conduct the Electrical audit in Branches/ATMs/ Office will be issued from our Office in the name of that staff.
- 6) There will be no escalation of rate during the period of rate contract.
- 7) No space will be provided for site office, labour camps, storage etc.
- 8) Canvassing in connection with tender is strictly prohibited and the tenders submitted by the applicants who resort to canvassing will be liable to rejection.
- 9) No payment will be made towards expenses related to transportation, accommodation, food, site Office, labour camps, storage etc.
