- b. UCO Bank does not guarantee the weight or purity of the Jewllery/ornaments/coins, either of its gold contents or otherwise;
- c. Bank reserves the right to cancel/stop or postpone the auction process/auction proceeding at any stage without assigning any reason or without any prior notice without any obligation. In case auction fixed on a day is cancelled/stopped or postponed, the earnest money shall be refunded to the respective bidders
- . d. Bank can withdraw any single or more than item from the auction at any stage of the bidding process till handing over to the successful bidder.
- e. The ultimate decision regarding acceptance of an offer/bid for purchase of jewellery/ornaments/coins through auction would be that of the Bank and Bank is not bound to accept the highest offer.

- j. The jewellery/ornaments/gold will be handed over to the highest bidder on payment of the entire bid amount, including the Earnest Money Deposit, within twenty-four hours or on the next working day of the Bank during its business hours. No request for extension of time will be entertained. In case a bidder, whose bid has been accepted,

fails to deposit the entire bid amount, or part thereof, within twenty-four hours, or the next working day, such bidder shall forfeit the Earnest Money and the jewellery/ornaments/gold will be put to auction.

k. The unsuccessful bidders shall be entitled for refund of their EMD immediately after the auction. Bank shall endeavor to refund the Earnest Money Deposit of unsuccessful bidders

I.
