NOTICE FOR EMPANELMENT OF ARCHITECTS, CONTRACTORS FOR CIVIL, INTERIOR AND ELECTRICAL WORKS.

Eligibility Criteria.

- 1. Persons who have Graduate/Post graduate Diploma in Architecture/ respective branch of engineering either from India or abroad and/or have done considerable extent of work as consultant for a period of more than 3 years.
- 2. They should be members of Indian Institute of Architects/ council of Architecture/institution of engineers or any of the professional institutes.
- 3. They should have been empanelled/ registered with any government department/public sector banks and hold a valid registration,
- 4. They should have successfully executed at least 3 woks for any bank/reputed organization.

Contractors

- 1. Should have experience in the same line and having successfully executed at least three works of similar nature in the last three years, for any reputed organization.
- 2. Contractors shall possess valid electrical licence from State electricity Authorities.
