Senior advocate R S Mazumdar, representing Congress's Tiwari, argued that the CBI special court did not have powers to issue "contempt of court" notice directly to the party concerned. "It can, at best, recommend for the same to the high court," Mazumdar argued.

After hearing out the arguments, the bench of justice Aparesh Kumar Singh set aside the lower court's contempt notices issued on January 3.

Earlier on December 23 last year, the special CBI judge Shivpal Singh had convicted Lalu Prasad and 15 others in the fodder scam case related to fraudulent withdrawal of Rs 89.27 lakh from Deoghar treasury.

Soon after the judgment came, political leaders gave their reactions before the media. Some of these didn't go down well with the court which subsequently issued contempt notices to the aforesaid leaders.
