Kolkata, Sep 28 (IANS) Blast ing the Mamata Banerjee government, BJP Working President J.P. Nadda on Saturday alleged that West Bengal wain the grip of "jungle raj" and "state terrorism" with democracy rendered non-functiona through "physical liquidation of political opponents".

"There is jungle raj in Wes Bengal. It is state terrorism Democracy is not being allowed to function. Democracy is being throttled," Nadda said after performing the Hindu ritual of tarpan -- offering of prayers to the departed -- for party workers killed in

He alleged those opposed to the ruling Trinamool Congress ideology were being killed.

"Every day, there is physical liquidation of people who have
