Vijayawada: A day after issuing a government order (GO) to rename an award scheme for students after his late father YSR, Andhra Pradesh chief minister Y S Jaganmohan Reddy withdrew the order on Tuesday because of a backlash from opposition parties and student bodies.

The education department had said on Monday the Dr APJ Abdul Kalam Puraskar Pratibha would now be known as YSR Vidva Puraskar. The award is given to students who excel in the Class X board examination. Jagan himself is said to have expressed anger over the order and directed officials to cancel it immediately.

The then TDP government had started the awards scheme in the name of Dr Kalam, which received a huge response from students and was considered a prestigious award.

TDP, Jana Sena, BJP and the Left parties slammed the government for issuing the controversial GO. 'Dr Kalam is the missile man of India. His life story is an inspiration for present-day youth. Renaming welfare schemes and painting walls with party colours have become a habit for YSRC. The government must cancel the GO immediately," Jana Sena's Razole MLA Rapaka Varaprasad had said.

"Dr APJ Abdul Kalam is a visionary and role model to every citizen of India. He is the heart of every Indian as a kind-hearted President of India. The YSRC government ignored him and changed the name of the prestigious award," TDP spokesperson Panchamarty Anuradha said.
