Ex-minister's petition for passport rejected

GURUGRAM, MAY 24

A court today dismissed the plea of former minister Sukhbir Kadetaria, one of the accused in an alleged bogus vote scam, seeking the return of his passport seized by the Gurugram police. The court said the former minister did not deserve it (passport).

Kataria, an ex-MLA from Gurugram Assembly seat, along with some of his relatives, a domestic help, a few block-level and Food and Supply Department officials were booked in the case after a district court issued the order to lodge a fresh complaint against them in May last year.

Om Prakash Kataria, a volunteer from Gurgaon Gaon, Kataria's native village, had asked the district court to file an FIR against the accused.

Kataria's passport was impounded by the Gurugram police last year after an FIR was registered in the Sector 5 police station. He had filed a petition in the court of Judicial Magistrate 1st Class Sukhdev Singh for the return of his passport.

Kataria said his son had completed LLB and wanted to go abroad for higher studies. He urged the court to

return his passport as he desired to go with his son for admission in a university there. In his status report submitted in the court, Bijender Singh, a police officer, said Kataria's son had not completed LLB yet. He said a case of using unfair means during the exams at the MDU, Rohtak, had been pending against Kataria's son and he had also failed in the fifth semester.

The court rejected Kataria's plea on the basis of the police report.

Kataria, who was a minister during the second term of Bhupinder Singh Hooda-led Congress government, has also been accused of misusing public fund. He has been facing 32 cases of bogus votes in different courts. — IANS

GangofATM hackers busted, twoarrested REWARI, MAY 24 The police have busted an

inter-state gang involved in duping bank customers after hacking ATMs and arrested two of its members.

The accused have been identified as Vicki of Tijara and Vinod of Gujar Ghataal village here.

SP Sangeeta Kalia said the gang was active in Rajasthan and south Haryana. The accused have confessed to having involvement in 28 cases of ATM frauds. She said four of the gang members had been identified through CCTV cameras installed at ATM booths. "The accused, along with other gang members, had fraudulently withdrawn Rs 15,000 from the ATM booth of OBC Bank on the Garhi Bolni Road here on April 23 last," said the SP, adding that hunt was on to nab their accompices. — TNS

Rights panel seeks report from varsity

The Harvana Human Rights Commission (HHRC) has sought a report from the Registrar, Indira Gandhi University (IGU), Meerpur, on the alleged harassment of an assistant professor, who protested allotment of a flat to a colleague junior to her.

Sources said Justice HS Bhalla, acting chairperson of the commission, has asked Registrar Madan Lal Goyal to submit the report before July 17, the next date of hearing in the case.

In his complaint to the HHRC, advocate Shingara Singh said his daughter Pinki Rani, an assistant professor in the commerce

department, had applied for a Type IV newly constructed flat on the campus. "My daughter is eligible for allotment on the basis of seniority, but the House Allotment Committee ignored her claim. It allotted a flat to an assistant professor junior to my daughter. Pinki registered her protest, but to no avail," Singh said.

"Pressure is being mounted on my daughter to stop resisting. I urge the authorities to take action against erring officials so that my daughter can be saved from harassment," Singh added. The Registrar said that

100 days of protest, Dalits won't give up

Protest by members of the Dalit A Mahapanchayat in Jind in support of their demands has completed 100 days. Activists are demanding segregation of the Scheduled Caste beneficiaries and retain 10 per cent extra quota for the 'A' category communities.

Devidas Valmiki, spokesperson of the mahapanchayat, blamed the BJP for not fulfilling its poll promise to ensure a quota within reservation for the SC 'A' community. He alleged that job share of 'A' category of the SCs had decreased significantly due to wrong policy framed by the previous Congress regime.

Devidas said despite making representation twice to Chief Minister Manohar Lal Khattar recently, there was no move by the state government. He added that the government made a precondition to end protest to discuss demands.
