- 1) Property is being sold on "As is and Where is" & "As is what is basis" & whatever there is basis" and without recourse basis". Intending bidders are advised to conduct search in Revenue / SRO records to satisfy title, identity, extent, dimensions, survey number, door number, boundaries or encumbrances in regard to the property proposed to be sold.
- 2) Intending bidders shall hold a valid Digital Signature Certificate (Class II / Class III). Interested bidders to access the portal / website of the e-Auction Agency (viz., https://ucobank.auctiontiger.net) and register themselves for getting User ID and Password.
- 3) Bids should be submitted only ONLINE in the prescribed form. Online bids can be submitted by accessing the website https://ucobank.auctiontiger.net. Bids should be submitted online on or before 10.09.2018 up to 5.00 P.M. IST. Separate bids should be submitted for each item of property.

The remittance details must be clearly indicated in the bid form. EMD amount remitted by unsuccessful bidders shall be returned to them by the Bank without interest. In the event of cancellation of auction also, EMD amount shall be returned by the Bank without interest. 6) A copy of the bid form along with its enclosure(s) submitted on line and duly signed Declaration (attached hereto) shall be sent to The Authorized Officer & the Branch Manager so as to reach the same on or before 10.09.2018. The Bank shall not

The Authorized Officer reserves absolute rights to accept or reject any one or more bids or to postpone / cancel the Auction without assigning any reason.
- 8) Auction / bidding will be only through online e-bidding. Online bidding will commence from the highest bid quoted among the bids and the minimum increase for each bid will be only for Rs. 10,000.00 or multiples thereof for all items of properties.
