The tender should be submitted in two envelopes i.e. Part A(Technical Bid) & Part B(Financial Bid). The offers received within prescribed time period will be opened in Zonal Office, Indore in presence of the contractors or their authorized, representatives whosoever wish to remain present. Quotation received after due date and time will not be considered.

- 4. Earnest Money Deposit(EMD): Rs 15,000/- in form of payorder/ DD in the name of the UCO Bank, Zonal Office, Indore payable at Indore (To be attached with tender). EMD of unsuccessful bidder will be refunded after completion of tender process and of successful bidder will be refunded after erecting and providing the required structure, to the satisfaction of Bank. In case of failure to execute the work, for whatsoever reason, EMD will be forfeited by the Bank.
- 5. Tender without cost of tender document and EMD will not be entertained.
- 6. The price quoted in tender should be all inclusive including all taxes. Bank will deduct TDS as per rule from the payment.
- 7. The bidder is required to enclose self attested photocopies of the following documents along with the tender (Part A) failing which their bid shall be summarily/ outrightly rejected and will not be considered any further.

- a) Valid VAT registration
- b) Valid PAN card & Income Tax return for assessment year 2013-14, 20142015 and 2015-16.
- c) Certificates of successful completion of similar work.
- 8. PAYMENT TERMS: No advance will be given to successful bidder. Payment of 80% amount agreed will be made on successful erection of temporary Bank premises, as per satisfaction of Bank and remaining 20% will be paid after completion of period of SIMHASTH 2016.
- 9. The contractor will be responsible for all related Govt rules, labour rules, etc. and indemnify the Bank in this regard.
- 10. The structure erected should be sound to withstand high wind, rain etc. Any hazard due to weak construction of premises and for faulty electrification shall be considered as adverse factor towards release of payment and the successful bidder shall be held liable and penalty will be imposed by Bank to the tune of losses faced by Bank, due to mishap.
