Re-lodgement of Physical Share Transfer Requests – Special Window (SEBI Circular Dated July 2, 2025)

Pursuant to the Securities and Exchange Board of India (SEBI) Circular No. **SEBI/HO/ MIRSD/MIRSD-PoD/P/CIR/2025/97** dated **July 2, 2025**, a **special six-month window** has been opened for shareholders to re-lodge physical transfer requests of shares that were:

- Originally lodged before April 1, 2019, and
- Rejected, returned, or left unattended due to deficiency in documents/process.
- **Window Period:** July 7, 2025 to January 6, 2026

***** Key Points:

- ♣ Shareholders can now re-submit their earlier rejected/returned physical share transfer requests during this period.
- **♣** All such transfers will be processed **only in dematerialised form**.
- ♣ Shareholders are requested to approach our **Registrar & Share Transfer Agent (RTA)** with requisite documents for re-lodgement.
